



## WAIVER OF LIABILITY AND RELEASE

I am the parent or legal guardian of the child whose name and birth date appear below. In return for allowing my child's participation in and attendance at the Pro Football Hall of Fame First Play/NFL Super Bowl High School Honor Roll Event to be held on Thursday August 6, 2015 at the Pro Football of Fame in Canton, Ohio and all related events and activities (collectively, the "Event"), I, on my own behalf and that of my child, release and agree not to sue the Pro Football Hall of Fame, National Football League (the "NFL"), its member professional football clubs, NFL Ventures L.P., NFL Properties LLC, NFL International LLC, NFL Enterprises LLC, NFL Productions LLC, CBS Broadcasting Inc., Wilson Sporting Goods Co. and each of their respective officers, parents, affiliates, subsidiaries, successors and assigns and their respective owners, shareholders, directors, governing board, employees, subcontractors, sponsors, agents, representatives, heirs, designees and licensees (collectively, the "Program Entities"), and each operator and owner of the respective venue locations (together with the Program Entities, the "Releasees") from all present and future claims that may be made by me, my child, my family, estate heirs, or assigns for property damage, personal injury, or wrongful death arising as a result of my participation in the Event and related activities wherever, whenever or however the same may occur. I understand that and agree that the Releasees are not responsible for any injury or property damage arising out of the Event, even if caused by their ordinary negligence. I understand that my child's participation in the Event involves certain risks, including, but not limited to, serious injury and death. On behalf of my child, I assume all risks associated with my child's voluntary participation in the Event. I understand that the Event may be filmed and by attending the Event, I consent to my child being photographed, videotaped and/or recorded. I consent to such photography, videotaping and/or recording and to any use, in any and all media formats, including, without limitation, television and digital media and formats, whether now known or hereafter devised, (including but not limited to a co-branded commercial or PSA with any NFL sponsor or licensee (e.g., XBOX)) throughout the universe in perpetuity, of my child's name, nickname, image, likeness, voice, photograph, signature facsimile, and biographical information for any purpose whatsoever, without any further action required or any consideration owing to me or my child from the Releasees. I understand that this document is intended to be as broad and as inclusive as permitted by the laws of the state in which the Event is taking place and agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect. I further agree that any legal proceedings related to this waiver of liability and release will take place in Canton, Ohio. I also agree that I may be photographed, videotaped and/or recorded in connection with the Event. By signing this waiver, I consent to such photography, videotaping and/or recording and to any use, in any and all media formats, including, without limitation, television and digital media and formats, whether now known or hereafter devised, (including but not limited to a co-branded commercial or PSA with any NFL sponsor or licensee (e.g., XBOX)) throughout the universe in perpetuity.
