### **SUPER TRIP 2020**

### **OFFICIAL RULES**

#### NO PURCHASE NECESSARY TO ENTER OR WIN

### A PURCHASE WILL NOT INCREASE CHANCES OF WINNING

#### 1. SPONSOR:

The Super Trip 2020 Sweepstakes (the "Sweepstakes") is sponsored by the National Football Museum Inc. d/b/a Pro Football Hall of Fame ("PFHOF") located at 2121 George Halas Dr. NW, Canton, OH 44708 ("Sponsor").

### 2. ELIGIBILITY:

The Super Trip 2020 Sweepstakes is open only to legal U.S. residents, residing in the continental U.S., who are at least 21 years of age or older as of December 31, 2019. Officers, directors, and employees of PFHOF are not eligible to win. Immediate family members (spouses, parents, children, and siblings, and their spouses and those living in the same household of such persons (whether or not related thereto) are not eligible to win. By participating, entrants agree to be bound by the Official Rules and the decisions of the Sponsor. All federal, state and local laws and regulations apply. Void wherever prohibited by law and outside the listed country.

### 3. TO ENTER:

No purchase is necessary, and a purchase does not increase chances of winning. The Sweepstakes begins on October 18, 2019 at 12:01am Eastern Time ("ET") and ends on December 31, 2019 at 11:59pm ET ("Promotion Period"). The time will be determined by the Sponsor's timekeeping systems. The Sponsor will have the sole discretion in determining the timeliness of any action or inaction related to this Sweepstakes. All times mentioned in these Official Rules are Eastern Time.

During the Promotion Period the Sweepstakes may be entered by anyone that meets the eligibility requirements, by registering at the PFHOF contest kiosks located in the lobby at 2121 George Halas Dr. Canton, Ohio 44708. No paid entry to the Hall or any other purchase is required to register.

All information provided must be truthful, accurate and complete. Upon successful completion and submission of an entry, one entry of a person over 21 will be entered into the Sweepstakes.

Received entries become the property of Sponsor and will not be returned.

No mechanically reproduced entries of any kind permitted. Illegible and incomplete entries are void. Sponsor is not responsible for lost, late, mutilated, misdirected entries or entries not received. If there is a dispute over who submitted an entry, the entry will be deemed to have been submitted by the authorized account holder of the email account identified on the entry form. The authorized account holder of an email account is deemed to be the natural person who is assigned to an email address by an Internet access provider, service provider, or online organization responsible for assigning email addresses for the domain associated with the submitted email address.

#### 4. PRIZE:

- One Grand Prize Winner will be selected to receive a 'Super Trip 2020'. The Grand Prize is a 2020
  Super Bowl Package from HOF Experiences and includes the following:
  - Two (2) tickets to Super Bowl LIV at Hard Rock Stadium in Miami on February 2, 2020;
  - Two (2) Round trip airfare tickets from an airport closest to the winner's home address to Miami, departing January 30, 2020 and returning February 3, 2020;
  - One (1) Four-night hotel accommodation in the Miami area (check-in January 30, 2020 check-out February 3, 2020);
  - Ground transportation or vouchers to access ground transportation to events included in the Grand Prize will be provided;
  - Two (2) tickets to the "Gold Jacket Autograph" session;
  - Two (2) tickets to "Gold Jacket Club" Pregame Party.

Approximate retail value of the Grand Prize, without airfare, is \$13,318. Final retail value will be determined after the winner is chosen.

Prize consist of only those items specifically listed as part of the prize. Sponsor reserves the right to substitute any prize with a prize of equal or greater value in its sole discretion. Federal, state, and local taxes on prizes, if any, and any other costs, fees and expenses not listed above as specifically included as part of the prize are the sole responsibility of Winner. An IRS Form 1099 and other tax-related forms and documents may be issued by Sponsor if required by law.

Prizes are non-transferable and non-refundable, and no substitutions by Entrants will be permitted.

# 5. WINNER SELECTION:

One Winner will be selected by computerized random drawing on or about January 3, 2020 from all eligible entries received during the Promotion Period. Decisions of the Sponsor are final on all matters. Odds of winning will depend upon the number of eligible entries. No substitution or transfer/assignment of prize by Winners is permitted. Winner must complete the prize paperwork within three (3) business days of notification.

## 6. WINNER NOTIFICATION AND RELEASES:

On or around the drawing date, Sponsor will attempt to notify the potential Winner via email. If a potential Winner: (a) does not respond after the first attempted contact from Sponsor within 48 hours, (b) is not in compliance with these Official Rules, (c) does not meet the eligibility requirements, (d) declines the prize, or (e) does not sign and return required documents or provide required identification by deadlines established by the Sponsor, Winner will be disqualified and the prize awarded to an alternate winner as determined by random draw from the remaining eligible entries. Sponsor will conduct up to one alternate drawings for the prize, time permitting.

Sponsor reserves the right to cancel or modify the Sweepstakes or any portion of it for any reason, including but not limited to, if fraud, misconduct or technical failures destroy the integrity of the Sweepstakes; or if a computer virus, bug, wireless failure, or other technical problem corrupts the administration, security, or proper administration of the Sweepstakes as determined by Sponsor, in its sole discretion. If Sponsor terminates the Sweepstakes, Sponsor will pick the winner(s) in a random drawing from among all eligible, non-suspect entries received as of the termination date and will post notice of its action on Sponsor's website. Sponsor reserves the right to disqualify, freeze or prohibit the participation of an individual if fraud or tampering is suspected, or if the individual fails to comply with any requirement of participation or with any provision in these Official Rules. Sponsor reserves the right to disqualify any individual from further participation in the Sweepstakes if Sponsor concludes, in its sole discretion, that such person: (a) has attempted to tamper with the entry process or other operation of the Sweepstakes; (b) has disregarded or has attempted to circumvent these Official Rules; (c) has committed fraud or attempted to undermine the legitimate operation of the Sweepstakes; or (d) has acted toward Sponsor, any Sponsor's Affiliates, or any other entrant in an unfair, inequitable, annoying, threatening, disrupting or harassing manner. If a dispute arises regarding compliance with these Official Rules, Sponsor may consider, in its sole discretion, data reasonably available to Sponsor through information technology systems in Sponsor's control, but Sponsor will not be obligated to consider any data or other information collected from any other source. Any attempt to undermine the operation of this Sweepstakes may be a violation of criminal and civil laws. Sponsor reserves the right to disqualify and/or seek damages from any individual making any such attempts to the full extent permitted by law. Any failure by Sponsor to enforce any of these Official Rules will not constitute a waiver of such Official Rules. If any provision(s) of these Official Rules are held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.
